TEEN FASHION SCENE MODEL RULES

1. A completed waiver form signed by a parent/guardian must be turned in with application.
2. All clothing attire and other accessories worn during the Fashion Show must be returned after the event to the Cypress and La Palma recreation staff.
3. Participants are required to remain on the premises until the end of the Fashion Show.
4. Proper dress requested before and after the Fashion Show (no strapless, single strap and/or backless tops, mini skirts, excessively baggy pants-they must be at the waist with a belt and pant length cannot be on the floor).
5. No loitering on the grounds before or after the event.
6. If you would not do it or say it at school, you may not do it or say it here!
7. Zero tolerance policy for fighting, drugs, and alcohol. Any involvement in these will result in your immediate removal from the event, possible loss of privileges to participate in future teen events, and possible prosecution under the law.
8. The City of Cypress and the City of La Palma are not responsible for any teen prior to their entrance into the facility during dress rehearsals and the day of the event.
9. City employees reserve the right to use their personal judgment in deciding proper behavior. Anything thought to be inappropriate will result in an immediate call to parent/guardian and removal from the fashion show.
10. All clothing worn by the models during the fashion show must be approved by the cities of Cypress and La Palma Recreation Staff.
